2025/26 Tuition, Program, and Course Fees

PURPOSE: This report will describe the process taken to assess Laurier's tuition rates across three major categories: Domestic Tuition, International Tuition, and Cost Recovery & Non-Credit Tuition. Management has proposed 2025/26 tuition rates below for your consideration.

Introduction

Post-secondary institutions in Canada are facing substantial financial challenges. Significant inflation, frozen domestic tuition rates, increased competition nationally and abroad for international student enrolment, and recovery from the COVID-19 pandemic continue to create unprecedented uncertainty as the University is forced to imagine what this and future academic years will look like under a set of entirely novel conditions and constraints. The annual tuition-setting process is an important exercise that balances the health of Laurier's most significant revenue stream with the reality of increasing program delivery costs, desired positioning within the Ontario postsecondary landscape, and student perception.

Laurier's tuition rates fall into three primary categories: **Domestic Tuition**, **International Tuition**, and **Cost Recovery & Non-Credit Tuition**. Management's approach to evaluating and setting tuition rates in each of these categories is described below. The majority of analysis within this report relates to international tuition rates by examining Laurier's market positioning, projecting rate increases at other Ontario institutions, and subsequently proposing 2025/26 tuition rates that address market conditions, expected international demand, and program value.

All rates presented in this report are effective May 1, 2025 unless otherwise indicated. Rates are reviewed by Laurier's Senate Executive and Finance Committee, the Board Finance, Investment & Property Committee, and Senate, and is approved by the Board of Governors.

Domestic Tuition

The Ministry of Colleges and Universities (MCU) provides a regulatory framework that governs the fee setting for publicly funded tuition fees and the application of the framework for tuition fee set-aside, billing, and program fee policy. The cost of attending university varies by Canadian citizenship or residency, provincial residency, and by program.

The current MCU Tuition Fee Framework provides guidance for domestic tuition rates across four academic years (2023/24 through 2026/27). Past MCU Tuition Fee Frameworks prescribed a 10% tuition fee reduction in 2019/20 and subsequent tuition fee freezes in 2020/21, 2021/22, and 2022/23. Under the current framework, domestic tuition rates for Ontario students are also to remain frozen (2023/24 through 2026/27) with the exception of (up to) three programs at each institution where the MCU deemed there to be a tuition anomaly (programs with a tuition rate >15% below the average program rate in Ontario). Laurier was approved to increase the domestic tuition rate by 7.5% for new students entering year one of BBA (and affiliated double degree programs), BA & BSc Computer Science, and BSc Data Science programs. In 2025/26 the domestic tuition rate for Laurier's BBA program will reach its target rate with an increase of 3.6%; however BA & BSc Computer Science, and BSc Data Science programs continue to be eligible for increases of 7.5%.



The 2021/22 MCU Tuition Fee Framework implemented a new policy whereby Canadian citizens/permanent residents who reside outside of Ontario at the time of their admission may be charged a higher tuition fee than students applying from within Ontario in equivalent programs. The MCU Tuition Fee Frameworks permitted out-of-province domestic tuition increases of 3% in 2021/22 and 5% in each of 2022/23, 2023/24, 2024/25, and 2025/26. Laurier will begin to assess new and returning out-of-province students in undergraduate programs with a 5% tuition increase in 2025/26, as permitted by the MCU Tuition Fee Framework.

International Tuition

International students are not eligible for MCU operating grant funding and therefore are not included in the government's tuition fee framework and ancillary fee guidelines. The University has full discretion over the fee setting process related to international (visa) tuition fee changes. Rate increases in this report apply specifically to new students. Increases for existing Laurier students will mirror rate increases for new students, to a maximum of 5%.

The international tuition rate increases proposed below have been developed by Management with input from the Faculty Deans, International Recruitment & Partnerships, Enrolment Services, Faculty of Graduate and Postdoctoral Studies, Institutional Research, and other staff.

WLU's international tuition rates were compared to similar programs at other institutions within Ontario. Recruitment and application data was utilized to identify those comparable programs as a frame of reference. Laurier's Institutional Research team has consolidated and validated the underlying data that supports management's analysis. The average tuition rate was calculated and a recommended tuition rate change was selected to align with the expected international demand and program value offered by WLU's degree/program.

Increases to international tuition rates in undergraduate programs enable us to cover the rising cost of program delivery while strengthening student supports and enhancing Laurier's capacity to award both merit and needs-based scholarships and bursaries.

Tuition guarantee for international students

In an effort to provide stronger financial predictability for international students, the University introduced an International Tuition Guarantee in 2023/24. International tuition rates will be established annually for each new incoming cohort of students. Once admitted, the tuition rates for continuing students will increase by no more than 5% between years of study. This guarantee means students will have stable, predictable annual tuition fees over the course of their degree.

Cost Recovery Tuition & Non-Credit Fees

The MCU excludes non-publicly funded (cost recovery) tuition fees and non-credit program fees from the tuition fee framework and ancillary fee guidelines. The University has full discretion over the fee setting process related to cost recovery and non-credit program fee changes. Tuition/fees for these programs are recommended by individual program owners in response to their specific delivery costs and market demand assessment.



Comparative Institutions

Management reviews tuition rates across all Ontario Universities using annual data collected by the Council of Ontario Universities.

The following five Ontario institutions have been identified as Laurier's market comparatives: McMaster, Guelph, Toronto, Waterloo, and Western. The comparatives were identified through discussion with Enrolment Services and Institutional Research, review of program offerings & market positioning, and is supported by University/College Applicant Study (UCAS) survey results.

Management's proposed rates in the sections below take into account Laurier's position in the overall Ontario University landscape with attention paid to these five comparative institutions.

International: Undergraduate Tuition Rates

The following rates are proposed for 2025/26:

BA & BSc Tuition

Laurier's 2024/25 BA & BSc tuition ranked #10 of 20 among Ontario Universities and #6 of 6 among WLU's institutional comparatives.

Management proposes a 5% increase to Laurier's BA & BSc rates for 2025/26. This equates to a \$1,660 annual increase (\$166 per 0.5 credit equivalent). This rate change is intended to cover rising costs of program delivery and maintain pace with market comparatives. At 5%, Laurier's rate increase is projected to be below forecasted 2025/26 increases at other Ontario institutions (informed by their rate changes taken over the past three years).

BBA Tuition (Business & Commerce)

The Lazaridis School of Business and Economics is AACSB accredited and engages students with immersive learning in relatively small class sections. Laurier's 2024/25 BBA tuition ranked #8 of 19 among Ontario Universities and #6 of 6 among WLU's institutional comparatives.

Management proposes a 5% increase to Laurier's BBA, BBTM, and associated double degree program rates for 2025/26. This equates to a \$2,011 annual increase (\$201 per 0.5 credit equivalent).



BSc/BA Computer Science Tuition

Laurier's 2024/25 BSc Computer Science tuition ranked #11 of 19 among Ontario Universities and #6 of 6 among WLU's institutional comparatives.

Management proposes a 5% increase to Laurier's BSc/BA Computer Science and BSc Data Science tuition rates for 2025/26. This equates to a \$1,794 annual increase (\$179 per 0.5 credit equivalent). This change responds to the increasing international demand for education in computer science fields, covers rising costs of program delivery, and maintains pace with market comparatives.

BBA/BMath and BBA/BCS double degree program Tuition

Laurier closed the gap between WLU and UW rates for these programs in 2020/21 and will continue to maintain parity in 2025/26. Laurier management has consulted with University of Waterloo and jointly proposed a 1% increase to BBA/BCS tuition and a 1% increase to BBA/BMath tuition. This rate change is intended to cover rising costs of program delivery with recognition of the current premium tuition rate.

The following rates are proposed for 2025/26:

MA & MSc Tuition

Laurier's 2024/25 MA & MSc tuition ranked #13 of 20 among Ontario Universities and #3 of 6 among WLU's institutional comparatives. Management proposes a 3.0% increase to MA & MSc rates for 2025/26. Taking a limited rate increase in this category enhances our ability to attract international graduate students while covering the rising costs of program delivery.



MBA Tuition (excludes cost recovery and Executive MBA programs)

Laurier's 2024/25 MBA tuition ranked #7 of 12 among Ontario Universities and #3 of 4 among WLU's institutional comparatives (Guelph and Waterloo did not offer a publicly funded MBA program in 2024/25). Management proposes a 7% increase to MBA rates for 2025/26.

MAC Tuition (Applied Computing)

Laurier reduced the MAC tuition rate from \$13,001/term to \$8,700/term in 2023/24 to better align with international tuition rates in similar programs at comparative institutions. This tuition reduction was accompanied by a program modification from 12 to 16 months (3 to 4 terms) to expand learning outcomes and make MAC more attractive to international students. Management proposes a 3% increase to Laurier's Master of Applied Computing program in 2025/26 to maintain pace with the increasing costs of program delivery.

MSW Tuition (Social Work)

Laurier's 2024/25 MSW tuition ranked #6 of 12 among Ontario Universities and #4 of 5 among WLU's institutional comparatives (Guelph does not offer a MSW program).

Management proposes a 3% increase to Laurier's MSW tuition rates for 2025/26. This equates to an \$843 annual increase (\$281/term). This 3.0% increase reinforces our market position and covers rising costs of delivering course practicum elements.

MMT Tuition (Music Therapy)

Management proposes a 3% increase to MMT tuition rates for 2025/26. There are six institutions across Canada offering an MMT program recognized by the Canadian Association of Music Therapist, only two of which are available in Ontario (Laurier and Toronto). Taking a limited rate increase in this category enhances our ability to attract international graduate students while covering the rising costs of program delivery.

PhD Tuition

Laurier's 2024/25 PhD tuition ranked #6 of 18 among Ontario Universities and #2 of 6 among WLU's institutional comparatives. Queen's University adjusted their fee structure in the 2023/24 academic year to bring international PhD rates in line with domestic rates. Carleton and McMaster took similar adjustments in 2021/22 and Ottawa, Western, and Toronto took similar adjustments in 2018/19.

Management proposes no increase (0%) to PhD rates for 2025/26. International students registered in research-intensive graduate programs also continue to receive a scholarship equal to the differential between international and domestic rates (this differential scholarship was \$12,786 in 2024/25).



Cost Recovery & Non-Credit Tuition

Tuition rates for these programs are set by individual program owners in response to their specific delivery costs and market demand assessment.

The following rates are proposed for cost recovery programs in 2025/26:
